# PARLIAMENTARY COMMITTEE SIMULATION - CLASSROOM HARMONY ACT

#### **Chair Instructions**

The chair of the committee is a parliamentarian (senator or MP) who has a very important job. The chair runs the meetings in an organized and fair way. Use the script below to organize what you will do and say at each stage of the meeting. When the words below are in *italics*, these are the words that you will actually say. You may change the wording slightly if you like.

If you are part of a simulation with a House of Commons committee, you are an MP and will refer to the House of Commons and MPs in the script. If you are part of a simulation in the Senate, you are a Senator and will refer to the Senate and Senators in the script.

Your teacher will indicate the time allotted for each section of the meeting and tell you if you should omit certain sections. The clerk or your teacher will time the proceedings. If the time allotted for a section runs out before everyone has had the chance to speak, you may wrap up the section. To do so you say:

The time allotted for	(section name) is up.	We will now move
on to	(name of the next section).	

#### Introductions

At the beginning of the meeting, introduce the work that the committee is going to do today, the speakers and the rules.

Good morning (or afternoon), honourable minister, committee members, honoured guests, ladies and gentlemen. Welcome to the Standing Committee on Learning, Innovation and Technology.

Today we will be examining an act to regulate the use of social media in the interests of classroom peace and harmony.

The Minister of Learning will introduce this bill to our committee, and then we will hear presentations from:

- The Anti-Facebook Coalition;
- High School Students' Rights Association;
- The 3Rs Defence League; and
- Federation of Social Media Providers.

We will then study and vote on each of the clauses in the bill, and have a final vote on whether or not to refer the bill back to the Senate/House of Commons. Here are some rules for the meeting:

- 1. Only parliamentarians on the committee are allowed to vote and to ask questions.
- 2. If you would like to speak or ask a question, raise your hand. The clerk will keep a list of people who would like to speak.
- 3. You may only speak or ask a question at certain times in the meeting, and when I have called your name.
- 4. Do not talk or whisper to each other during the meeting.
- 5. Speak respectfully to each other. You will call me Mr. / Madam Chair. You will call parliamentarians and the minister by their title and name, for example "Senator Smith" "MP Bilodeau" or "Minister Chan." You will call the witnesses Mr. or Ms. and their last name.

#### Witnesses

Introduce the part of the meeting where the witnesses offer their presentations.

We will now hear from our very welcome guests. Thank you for taking the time to travel here today to share your opinions and expertise with us. When I call on you, please come and sit in the witness seats to make your presentation.

Let's begin with the Minister of Learning. Minister, you have up to four minutes to speak.

Invite the minister to come up to the table to speak. When he or she is finished, ask the committee members if they have any questions or comments for the minister.

Repeat the procedures for inviting witness groups to make their presentations and answer questions from the committee until all the groups have been heard.

#### Clause-by-clause examination of the bill

You will now lead the committee members through the clauses in the bill. They will have a chance to talk about the specific words in each clause and then will have to vote on whether or not to approve each clause. You will skip the first two clauses that are simply about the title and definitions and will begin at clause 3.

We will now begin our clause-by-clause examination of the bill, starting with clause 3. For each clause, I will ask if there is any discussion. If you want to make an amendment, that is the time to introduce it. You introduce an amendment by saying "I propose that we amend this clause." You then explain the amendment and hand a written copy of it to the clerk. If you introduce an amendment, we will discuss and vote on it first. If the amendment passes, the clerk will change the wording of the clause. If it does not, the wording will remain the same.

We will vote on each clause by raising hands. I will say:

"If you want this clause to pass, please raise your hands" and then

"If you want to defeat this clause, please raise your hands."

The clerk will count the votes. If more of you vote for the clause to pass, it will stay in the bill. If more of you vote to defeat it, the clerk will remove it from the bill.

#### Final vote

The final vote on the bill is whether or not to report the bill back to the House of Commons/Senate. That means the committee is finished with the bill, and it is time to move it on to the next step.

Members of the committee, is it agreed that I report this bill to the Senate/House of Commons?

#### Conclusion

Thank everyone for their time and effort and say that the meeting is adjourned.
