For the purposes of this selection process, the competencies listed in the attached Competency Profile will be evaluated.

The following knowledge criteria will also be evaluated:

- · Knowledge of the Parliament of Canada, the federal government and current affairs
- Knowledge of international trade, national defence or international affairs

To be considered, candidates must have:

- Graduated with a bachelor's degree from a recognized university in a field related to the position between 2017 and spring 2019
- Experience preparing written material, including reports, briefing notes, background papers or presentations

Assets:

- Experience in preparing visual elements, such as charts and graphics, including with Excel
- International education or work experience

Candidates retained in this selection process will be required to obtain:

- A successful second-language evaluation (Bilingual staffing imperative: <u>CBC/CBC</u>)
- · A successful pre-employment screening

Additional Information:

- This selection process is open to the public and to employees of the Library of Parliament, the Senate, the House
 of Commons, the Office of the Senate Ethics Officer, the Office of the Conflict of Interest and Ethics
 Commissioner, the Parliamentary Protective Service, and the Office of the Parliamentary Budget Officer.
- This selection process will include a second-language evaluation, a written qualifying exam and an interview. The interview will consist of behavioural, situational and knowledge-based questions. Candidates will be required to pass each stage in order to proceed to the next stage of the selection process.
- Qualified candidates from this selection process may be considered for determinate or indeterminate positions at the Library of Parliament that require similar knowledge and/or competencies.
- Education and experience requirements will be used to determine which candidates will be asked to participate in the next stage of the selection process.
- Satisfactory references and proof of education are essential conditions of appointment.
- Travel and relocation expenses are the responsibility of the candidates.
- The Library of Parliament is committed to employment equity.



• Preference will be given to Canadian citizens and to permanent residents who are legally able to work in Canada. Applicants who have a valid work permit may also be considered.
