For the purposes of this selection process, the competencies listed in the attached Competency Profile will be evaluated.

The following knowledge criteria will also be evaluated:

- In-depth knowledge of Parliament, its institutions and processes, particularly with respect to the review of statutory instruments, including federal regulatory review process
- · Knowledge of the role of the Standing Joint Committee for the Scrutiny of Regulations
- Knowledge of legal principles governing the exercise of delegated law-making powers
- Knowledge of administrative law

To be considered, candidates must have:

- Membership in good standing in a provincial or territorial law society
- Experience in analysis of issues related to one or more of the following areas:
 - Regulatory law
 - o Statutory interpretation
 - o Administrative law

Asset:

- Experience in the review of statutory instruments
- Experience in the writing of legal opinions
- Experience managing human and financial resources
- Experience developing and implementing projects/initiatives, preferably in a parliamentary or government context

Candidates retained in this selection process will be required to obtain:

- A successful second-language evaluation (Bilingual staffing imperative: <u>CBC/CBC</u>)
- A successful pre-employment screening

Additional Information:

- This selection process is open to the public and to employees of the Library of Parliament, the Senate, the House
 of Commons, the Office of the Senate Ethics Officer, the Office of the Conflict of Interest and Ethics
 Commissioner, the Parliamentary Protective Service, and the Office of the Parliamentary Budget Officer.
- This selection process will include a second-language evaluation, a written qualifying exam and an interview. The
 interview will consist of a presentation and behavioural, situational and knowledge-based questions. Candidates
 will be required to pass each stage in order to move to the next stage of the selection process.



- Qualified candidates from this selection process may be considered for determinate or indeterminate positions at the Library of Parliament that require similar knowledge and/or competencies.
- Education and experience requirements will be used to determine which candidates will be asked to participate in the next stage of the selection process.
- Satisfactory references and proof of education are essential conditions of appointment.
- Travel and relocation expenses are the responsibility of the candidates.
- The Library of Parliament is committed to employment equity.
- Preference will be given to Canadian citizens and to permanent residents who are legally able to work in Canada.
